Interpretive sign system recommendations are general in nature. Many access sites around Humboldt Bay should incorporate some level of interpretive signing. The recommended interpretive sign format (page III-27) can also be used as a ‘mini-kiosk’ – in places where larger signs are inappropriate or that receive less public visitation – to present a wide range of site, safety and interpretive information while reducing the potential for ‘sign clutter’. Sites that receive heavy use should have numerous interpretive signs with different themes, while less-visited sites (or those places that managers want to maintain a ‘wild’ character) should have few (and sometimes none).
